THE PLANT HAD OPERATED SINCE ITS INCEPTION WITHOUT POLLUTION CONTROLS AND IS RESPONSIBLE FOR UP TO 50% OF THE AIR POLLUTION IN THE COLUMBIA GORGE WHEN GORGE AIR QUALITY IS AT ITS WORST.
